About Summer Institutes

[Summer Institutes Online \(SIO\)](#) is an academic enrichment program, serving students grades 8-11 at time of application. SIO offers intellectually curious students from around the world the opportunity to enroll in advanced single course subjects not typically found in the high school curriculum. Courses are held live on Zoom each weekday for two hours per day in two-week sessions.

Compensation

Compensation is tentatively scheduled to be approximately \$5,100 per course assignment.

Course Design

- Instructors are responsible for determining the content and all assignments and activities for their course, including assignments for students to complete outside of class hours.
- Course content must be consistent with the course description posted on the Summer Institutes website; approval is needed for changes in course content that stray substantially from the course description.

- You must use only age-appropriate material; if you have any doubt about the appropriateness of your material, please consult with us.
- You will be required to submit a course syllabus.
- Additionally, you will be responsible for posting course materials on Canvas prior to the start of class.
- Design a course with a grade level in mind, i.e., 8-11, 8-9, or 10-11 at time of application.

Synchronous (Live) Sessions

Instructors are responsible for scheduling and facilitating 2 hours (with a break) of learning activities each weekday during your assigned time range. Courses are assigned to an AM or PM time slot for instruction, within which you should schedule 2 hours of live activities with your class each weekday. Instructional time should be a combination of lecture, classroom discussion, student presentations and small group activities.

The time blocks for instruction and office hours (AM or PM) are as follows:

- AM – 8:00 am to 11:00 AM PDT
- PM – 4:00 pm to 7:00 PM PDT

Office Hours

In addition to live activities each weekday, you are also responsible for holding small group office hours twice per week during the instructional time block.

Self-Study

Each weekday students should be assigned independent work or small group activities. The required assignments and activities should take no more than 4 hours each day. You may assign optional supplementary activities.

Student Evaluations

You are required to write two paragraph evaluations of your students. This task is due no later than two weeks after the end of the session. These evaluations are sent to the Summer Institutes participants along with their completion certificate. The certificate and evaluation will require your signature.
